2. To only include all contract awards that are current i.e. services are currently being provided
3. To include only contracts/awards with an estimated annual value of a minimum of £1,000,000
4. To exclude awards made by local authorities for domiciliary care services
5. To include, but limited to; complex nursing care, healthcare services in the Prison service, NHS treatment centres, community nursing services, hospital services, out of hours services, NHS 111 services, urgent care services
6. To include a description of the service being provided
